

- When exiting back onto the main drive, please turn right and continue around the traffic circle until you are on the exit side of the main drive.

EXITING TO THE LEFT AS YOU LEAVE THE GRASS PARKING AREA AND CROSSING OVER THE MAIN DRIVE IN FRONT OF THE GUARDHOUSE IS PROHIBITED.

- Children should be supervised at all times.
- Only players and coaches are permitted inside the fenced area to the facility, with access limited to the turf field only; use of the track portion of the facility is prohibited when the turf portion of the facility is in use.
 - Spectators should remain outside of the fenced area of the facility at all times. Approved viewing areas are at the top of the hill surrounding the facility or outside of the fenced field area.
 - Guests wishing to exercise during practice sessions may walk on the sidewalk around the perimeter of the facility or on the public greenway that runs across the front of the campus (greenway access during daylight hours only).
- Players should refrain from wearing soccer cleats until they have reached the turf field portion of the facility, by wearing athletic shoes onto the synthetic track and then changing into their cleats once on the turf field itself.
- For hydration, water/clear liquids only are permitted. Please recycle used bottles in the furnished recycling receptacles.
- All trash, including used tape, nylon bands, etc. should be properly disposed in the furnished trash receptacles.
- No gum on the field.
- Skateboarding is prohibited on campus.
